

Official Rules:

The Association's Kitten Hijinks Contest, Sponsored by Boehringer Ingelheim

How to Enter:

From 12:00 AM (EDT) on July 28, 2025, to 11:59 PM (EDT) on August 10, 2025, animal welfare organizations may enter the Contest by completing the following:

1. Create a cute, silly, heartwarming or funny video of your kitten(s) doing kitten things. Visit www.theaawa.org/kittenhijinks, complete the entry form, and upload your video.

Each animal welfare organization may submit (1) entry during the contest period and agrees to the Contest Rules and Guidelines by submitting an Entry, successfully or otherwise.

Winner Selection: (20) winning Entries will be selected from all eligible Entries by The Association for Animal Welfare Advancement's (The Association) judging panel. The (20) winners will be notified by e-mail to the e-mail address with which they entered the Contest. (500) doses of *NexGard*[®] COMBO (esafoxolaner, eprinomectin, and praziquantel topical solution) will be provided to each of the (20) winners.

1. Create a cute, silly, heartwarming or funny video of your kitten(s) doing kitten things. Feature one kitten or a group of kittens, in their kennels, a playroom or another kitten-safe environment, on their own or with humans, toys, or other kitten-safe props.
2. Video Requirements
 1. 15–30 seconds in length
 2. Video must feature submitting organization's kitten(s)
 3. MP4 or MOV file types only
 4. Submission file size *must be less than 1 gigabyte*
 5. Organizations must be based in the United States
 6. Files must be uploaded to theaawa.org/kittenhijinks
 7. No inappropriate language, images, or sounds
 8. Submissions can be made between July 28–August 10, 2025

Eligibility: Animal welfare organizations (including animal shelters, spay/neuter clinics, municipal animal care and control, and rescue organizations) located in the 50 United States or the District of Columbia. This Contest is governed exclusively by the laws of the United States. You are not authorized to participate in the Contest if you are not located within the United States.
